

## Hussey Walsh Index of Contents

Some years ago Peter Manning, a longtime officer and fellow of the Society, undertook the mammoth task of indexing all names from the twelve volumes of the Library's Hussey-Walsh manuscripts. He writes: The manuscripts contain transcripts from original Irish, English & French historical & genealogical material ranging from the twelfth to nineteenth centuries. The completed index contains reference to over 100,000 persons. The manuscripts, once belonging to Valentine John Hussey-Walsh (1862-1925) of Mulhussey, Co Roscommon (with two volumes attributed to Tenison Groves), contain a total of 2,883 handwritten pages, much of which was taken from original records later destroyed in the fire at the Public Record Office of Ireland in 1922.

In addition to the index of names, Mr Manning also prepared a detailed list of contents, which appears below. While there is an emphasis on Co. Roscommon, each volume contains material which would be of general interest to all researchers. This Index of Contents has previously been published in a series of issues of the IGRS Newsletter.
